

| PAYMENT PLAN SCHEDULE |

- 1st installment is due at check in for your 1st treatment appointment.
- 2nd installment is due at check in for your 2nd treatment appointment.
- 3rd installment is due at check in for your 3rd treatment appointment.
- 4th installment is due at check in for your 4th treatment appointment.

| RULES AND RESTRICTIONS |

Late cancellations or missed appointments

- Late cancellation or missed appointments cost us valuable staff time.
- Prepayment is required to book your first laser hair removal appointment and all individual pay as you go laser hair removal treatments. This prepayment will be used toward your treatment cost. The prepayment is refunded if you cancel with 24 business hour's notice.
- Cancellations under 24 business hours before your appointment or missed appointments will be charged a fee of \$100 1st time, \$100 2nd time (\$350 fee for each full body treatment missed appointment as staff is reserved for hours for this treatment) to cover some of the time reserved for your treatment & a non-refundable prepayment is required to schedule next appointment.
- This charge will be deducted from prepayment amount, or, for packages, it must be paid before further treatments can be scheduled.
- If you are more than 10 minutes late, there will likely not be enough time to receive your treatment and you will have to be rescheduled. If your appointment is rescheduled due to a late arrival, it will be treated the same as a no show or late cancellation and fees will apply.
- Your treatment package and/or payment plan do not cover charges for missed appointments or late cancellations.
- If you cancel after business hours via voicemail or email, your appointment will be considered canceled at the start of the next business day.
- 3 late cancellations or missed appointments are grounds for terminating your treatments, voiding your package, and no refunds will be given.
- Please check your schedule and make every effort to keep your appointment or notify us well in advance to make changes so that you don't incur charges, lose the remainder of your treatment package, and waste valuable staff time.

Refunds

Your purchased laser hair removal treatment or package is non refundable once you have received your treatment or the first treatment of your package. No installment payments will be refunded. Refunds are not given for unused or remaining laser treatments.

Canceling Your Payment Plan

You can cancel your plan at any time during your first 4 treatments. Your purchased laser hair removal treatment or package can be canceled by not making remaining installment payment(s) and receiving no further treatment. No installment payments previously made will be refunded. Refunds are not given for unused or remaining laser treatments.
